

The Apostle Islands

October 10-13, 2024



The islands are noted for high cliffs of reddish sandstone with many wave-formed arches and caverns that develop magnificent scenery. The Apostle Island National Lakeshore has more lighthouses than any other site in the National Park System with 9 historic towers on 6 islands. The islands were probably named by 17th-century Jesuit missionaries for the Twelve Apostles. There are 22 islands in total.

Thursday, October 10th - This morning we set off on an adventure to Wisconsin's jewel of Lake Superior - Bayfield County and the Apostle Islands. We will venture across the ever-changing and enchanting landscape of Wisconsin as we head North. Our lunch will be in scenic **Minocqua**. This region is known for its gentle sloping plains that transform into rugged hills as we enter the **Bayfield Peninsula**. Named one of the "23 Best Places to Go in the US," Bayfield is a perfect gateway to experience the magic of Lake Superior. Our accommodations will be at the **Legendary Waters Resort & Casino** and we will have dinner tonight at a local favorite. (L,D)

Friday, October 11th - This morning, we will board the **Madeline Island Ferry** and make our way across **Lake Superior** to view the spectacular majesty of these islands. During October, the fall colors have transformed the lakeshore into a flurry of golds, reds, and oranges. We disembark on Madeline Island where our **local guide** will show us around the island, relaying its unique history and geological formation. There will be free time to explore the quaint shops and museums before we board the ferry back to the mainland. (B,D)

Saturday, October 12th - This morning we will board the **Island Princess** for a narrated, informative scenic tour of the islands. We pass extraordinary scenery, beautiful historic Raspberry and Devils Island Lighthouses, standing rocks, extensive sea caves, and marine wildlife. Lunch will be at the historic **Old Rittenhouse Inn** and our afternoon will be finished with a **guided tour** of Bayfield by a local expert. The evening is yours to explore. (B,L)

Sunday, October 13th - Today we depart for home and begin our journey south. We will make a stop at **Hauser's Superior View Farm**. The hub of the farm is their 1928 Sears Roebuck Red Barn which operates as their retail store and Apfelhaus Cidery tasting room. Homemade jellies, jams, and apple butter from delicious fruits grown on the property will be available to purchase. What a great time we had in Northern Wisconsin! (B)
