## **Apostle Islands**



## October 10-13, 2025 (4 Days)

The islands are noted for high cliffs of reddish sandstone with many wave-formed arches and caverns that develop magnificent scenery. The Apostle Islands National Lakeshore has more lighthouses than any other site in the National Park System with 9 historic towers on 6 islands. The islands were probably named by 17th-century Jesuit missionaries for the Twelve Apostles. There are 22 island in total.

Friday, October 10th—This morning we set off on an adventure to Wisconsin's jewel of Lake Superior—Bayfield County and the Apostle Islands. We will watch as we venture across the ever-changing and enchanting landscape of Wisconsin as we head north into the area known as the Lake Superior Lowland. Our lunch is in scenic Minocqua, with time to explore the many shops. This region is known for its gentle sloping plains that transform into rugged hills as we enter Bayfield Peninsula. Named one of the "Best Places to Go in the US," Bayfield is a perfect gateway to experience the magic of Lake Superior and the Apostle Islands. We check into the Legendary Waters Resort & Casino for the next 3 nights. Our dinner is a true supper club experience. (L,D)

<u>Saturday, October 11th</u>— This morning we will board the <u>Madeline Island Ferry</u> and make our way across <u>Lake Superior</u> to view the spectacular majesty of this islands. During October, the fall colors have transformed the lakeshore into a flurry of golds, reds, and oranges with magnificent hues. We disembark on Madeline Island, where our **local guide** will show us around the island, relaying it's unique history and geologic formation. There will be free time to explore the quaint shops and museums. **(B,D)** 

<u>Sunday, October 12th</u>— We spend the morning exploring Bayfield before a delicious lunch at the **Old Rittenhouse Inn**, a quaint Victorian Inn. We will board the **Island Princess** for a narrated, informative scenic tour of the islands. We pass extraordinary scenery, beautiful historic Raspberry and Devils Island Lighthouses, standing rocks, extensive sea caves, and marine wildlife. **(B, L)**
