On all cancellations, a \$50 per person administrative fee will be assessed after the deposit is made. Within 60 days of departure, however, you are at risk for all or part of your investment. Within 48 hours, this policy is void.

This plan will cover your investment from the time you make your final payment until 48 hours prior to your departure.
