Personalized Tours, Inc. has a very generous refund policy if you must cancel your trip **60** days or more before the departure date. The only exception is if theater tickets, non-refundable attractions, or non-refundable hotels are involved. In that case, we will refund only the funds that are returnable to us. On all cancellations, a **\$50** per person administrative fee will be assessed after the deposit is made. For cancellations within **60** days of departure, you are at risk of losing all or most of your investment. We would like to protect your investment by offering very affordable "Peace of Mind" cancellation protection on our multi-day, motorcoach-only tours for cancellations up to **48** hours before departure. ***Within 48 hours of departure, this policy is void.***

If you must cancel your tour because of illness or injury to yourself or your traveling companion or a death in the immediate family, "Peace of Mind" protection will credit you for the non-refundable portion of the tour. This plan will cover your investment from the time you make your final payment until **48** hours prior to your departure. You must have a doctor's or funeral director's written notice upon cancellation. Please be aware that should your travel partner find it necessary to cancel the tour, you will be responsible for the additional cost of a single occupancy should you decide to still participate in the tour. If you have also purchased "Peace of Mind" cancellation protection, you have the option to cancel the tour without penalty as specified above. **Peace of Mind reimbursement WILL be in the form of a TRAVEL VOUCHER with no expiration.**
