Personalized Tours, Inc. is dedicated to offering our travelers the finest tours available, and when it comes to protecting your investment, we are offering the very best cancellation protection in the industry at an affordable price. Please read through the following information — if you have any questions, feel free to give us a call.

Personalized Tours, Inc. has a very generous refund policy. Your tour deposit is refundable less a \$50 per person administrative charge, if you cancel 60 days or more before the departure date. The only exceptions are if theatre tickets or non-refundable attractions are involved, or we are working with another tour company that has a more stringent cancellation policy. In that case, we will refund only the funds that are retuble to us. Within 60 days of departure, however, you are at risk for all or part of your investment. We would like to protect your investment by offering very affordable "Peace of Mind" cancellation protection on our multi-day motorcoach-only tours. This protection is valid until 24 hours before departure. Within 24 hours of departure, this protection is void. With the purchase of "Peace of Mind" cancellation protection, the \$50 per person administrative charge is waived.

If you have to cancel your tour because of death, illness, or injury involving you, a travel companion, or an immediate family member, "Peace of Mind" protection will pay for the non-refundable portion of the tour. This plan will cover your investment from the time you make your final payment until 24 hours prior to departure. You must have a doctor's or funeral director's written notice upon cancellation. Please be aware that should your travel partner find it necessary to cancel the tour, you will be responsible for the additional cost of single occupancy should you decide to still participate in the tour. If you have purchased "Peace of Mind" cancellation protection, you have the option to cancel the tour without penalty as specified above.

"Peace of Mind" cancellation protection through Personalized Tours, Inc.
